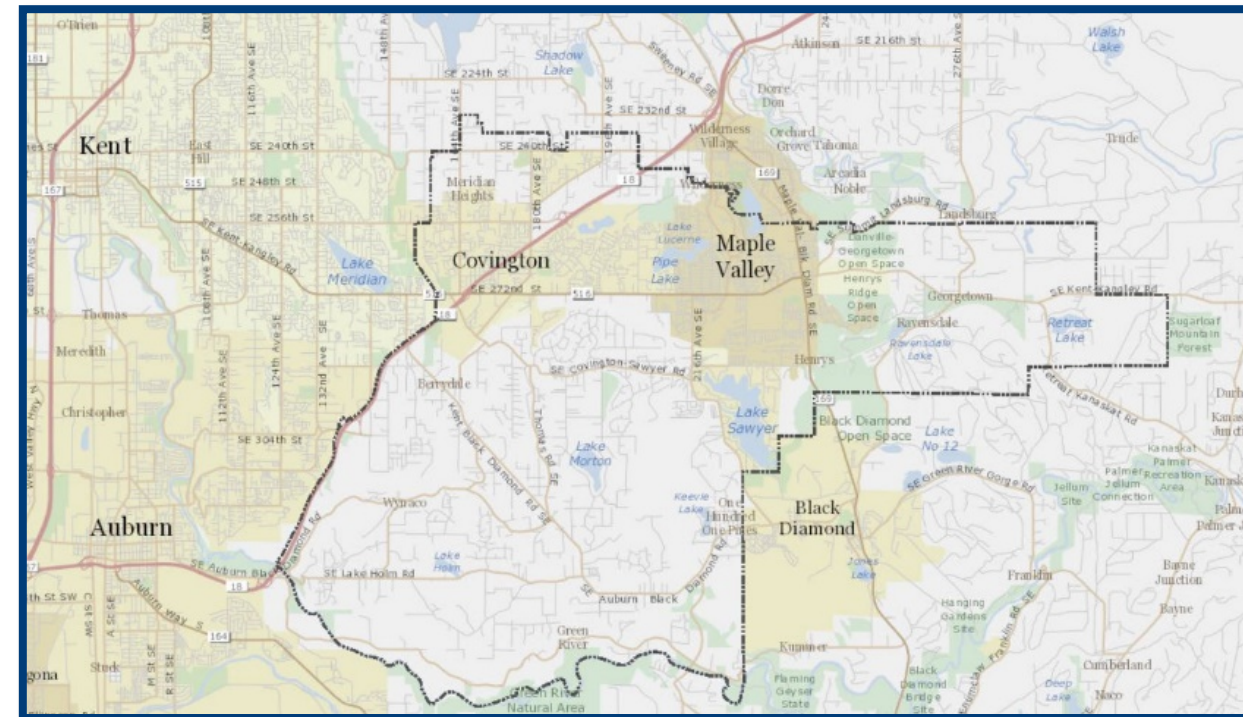

Covington Water District is a special purpose district responsible for providing clean, safe and reliable water to a 55-mile area in South King County, covering the cities of Black Diamond, Covington, and Maple Valley and some unincorporated areas of King County, Washington. The District serves a population of approximately 50,000 through 18,919 connections and provides a reliable supply of clean, safe water to residential homes, apartments, small farms, commercial, governmental, schools and medical facilities.

The District operations are governed by regulations implemented and enforced by the Washington State Department of Health. The District derives its authority from the Revised Code of Washington (RCW) Title 57. A five-member elected Board of Commissioners sets policy within the framework of state statutes and local ordinances.

Safe and reliable infrastructure comes from making good decisions about maintenance and investments. The District actively manages over 90,000 assets to ensure long-term sustainability.



Securing our Water Future



The District is working diligently to pursue projects that will provide water availability today and in the future. Recently, the District assisted in securing \$220 million for the Howard Hanson Dam.

This investment will allow the District to secure an additional 2,000 ac-feet of additional water supply to ensure long-term sustainability and value to our current and future customers.

Innovative Solutions

The District is interested in investigating and implementing cost-effective solutions to issues facing our community.

Recently we completed the installation of a turbine generator. This micro-hydro project captures energy that would otherwise be wasted as it moves through pipes. The District is currently offsetting 82% of our main campus' power.



Additionally, the District is investing in all-electric fleet vehicles that are charged from our turbine generator.
